By this call, you are officially notified of the annual meeting of The Beacon Falls Congregational Church, Beacon Falls, Connecticut, to be held on Sunday, January 21<sup>st</sup>, 2024, with a snow date of January 28<sup>th</sup>, 2024. #### Proposed changes to BFCC's Constitution and Bylaws to be voted upon at the Annual Meeting.

The Board of Deacons is proposing the following changes to BFCC's Constitution and Bylaws to be voted upon at the Annual Meeting in January, 2024. We seek to remove the current restriction that members can only serve two consecutive terms on a committee.

#### Rational behind this proposed amendment

- We should not limit people in serving with the Gifts God has bestowed on them individually.
- Continuity We seek parity with the unlimited terms of our church officers (Clerk, Treasurer, Asst Treasurers, Church School Superintendent and Auditor).
- Church members (in full and regular standing) will still annually elect those whom will serve as officers and on committees.

#### Proposed changes to be made:

A motion will be made at BFCC's Annual meeting in January, 2024 to Amend Sections of Article V – (Pastors, Officers, Non-Officers and <u>Committees</u>) as follows:

**Section 1 – Board of Deacons** – Delete the sentence "After serving two consecutive terms, a member will be ineligible for re-election to the Diaconate for one year".

**Section 2 – Prudential** - Delete the sentence "After serving two consecutive terms, a member will be ineligible for re-election to the Prudential committee for one year."

**Section 3 – Christian Education** – Delete the sentence "After serving two consecutive terms, a member will be ineligible for re-election to the Christian education committee for one year."

**Section 4 – Endowment** – Delete the sentence "After serving two consecutive terms, a member will be ineligible for re-election to the Endowment committee for a period of one year."

**Section 5 – Nominating** – Delete the sentence "After serving for two consecutive terms, a member will be ineligible for re-election to the same committee for one year."

The meeting was opened at 11:28 AM with prayer Pastor Jess.

Shannon Spence opened the meeting up with a demo on the Sign-up Central on the BFCC web site. This includes announcements of events happening within the church and to sign up for weekly Sunday worship opportunities. Shannon reviewed how to get to the sign up central and how to sign up for opportunities to help.

Marie Cameron did a presentation on the Raise Right (formerly Script) program and how to use the program to raise funds for the church either by using Ecards or physical gift cards. Marie reviewed history of usage by our church families. Contact Marie if information is needed to sign up or how to get physical cards.

Pastor Jess asked for nominations for Moderator, Judy Landry nominated Dave Spence, Kevin Laitenbeger nominated Joe Whitehead. Dave spence declined. Judy Monarca seconded the nomination for Joe Whitehead. Approved by all.

Joe reviewed the process and structure of the meeting, review of last meetings minutes, voting to accept committee reports at end of meeting.

The minutes from the 2022 annual meeting were reviewed. Deb h. noted a correction to the attendance list on page 4 should be Joanne King. A correction to the Warrant on page 3 was also noted; line item #3 should be December 31, 2023. A motion was made to accept the minutes with corrections by Liza W. second by Judy L. Approved by all.

The minutes from the 2022 Special meeting were reviewed. Judy M. questioned the numbers for the vote. Liza explained the difference is due to someone not submitting a vote either way. Motion to accept minutes by Martha B, second by Julia S, approved by all.

#### **Review of Committee Reports:**

The Church Council report was reviewed by Pastor Jess. Pastor Jess indicated it was a challenging year reviewed council process. Spirt of God has led us through or walk.

The Clerk's statistical report was presented by Marsha Culik. Numbers reviewed by Joe. Thanks to Marsha for serving as clerk for all the years.

The Christian Education report was submitted by Johanna F. Continuing to look for volunteers to help out. Jess

indicated that this is a critical need for our Sunday School ministry. Tricia indicated that curriculum is easy to use and includes information and activities. Julia asked about teaching the kids the Lord's Prayer. Shannon indicated that this is part of the hand out that goes home in the welcome packet that goes home with each family. Will consider added as part of curriculum.

The Bible Study Ministry Team report was presented by Wendy Anderson. Reviewed upcoming study list. All are welcome to attend. Have a movie night coming up. Martha brought up the possibility of a beginners Bible study if there is interest.

The Diaconate report was presented by Judy Monarca. It was a busy and challenging year. Judy offered to continue as chairperson of the committee this upcoming year. Thanks to all Deacons. Julia S. asked what happened to the song "Let us Break bread together" song on communion Sunday. Lisa S, also indicated interest in this song being added back in. Deacons will discuss at the next meeting.

The Community Outreach Ministry team report was presented by Wendy Hopkinson. Thanks to team for all their work. Existence for 4 years and have challenged church and community to help ministry.

What is new this year –

- Sharing Shed waiting to be moved to gravel area. Thanks to Pete Betkowski/John Conte for help with the shed. Partnering with the Mobile food pantry, working with town, to be established in fire house parking lot.
- Town of Beacon Falls tax abatement; 65, home owner, income not over 75K. \$500 amount. We will supply fliers. Need to apply in person. Starts Feb 1<sup>st</sup> through April. Information on town website. Contact Lisa Daigle in Town Hall for information.

Need help with Welcome bag ministry. Struggling with creation of bags. Wendy explained what goes into the bags. 60 behind, need help assembling. Denise Hendricks volunteered to help out assemble the bags. Concerned about budget line item being cut and asked to consider adding monies.

Look for volunteers to open and close the shed. There is a need – currently servicing 40 people, 19 households with fresh food deliveries.

Endowment Report was submitted by Marie Cameron. Lost some committee members. Challenging year with fund loss, however we continue to invest. Discussion on what committee does – they meet twice a year and meet with investment advisor twice a year to review investments. Investing at a moderate risk level.

Memorial Fund report given by Liza Whitehead. Refer to annual report.

Pastor's report was presented by Pastor Jess. Pastor Jess discussed that he has started a Men's group meeting regularly reviewing Family Shepherds; Finished up Gentle and Lowly in April. Has been disciplining others throughout the year. Lisa Swanson asked about other tasks that he has been doing such as at home, hospital visits. Jess shared other tasks that he has been doing, firehouse etc. It was asked that he highlight these items in annual report.

Joe introduced Tracey, our new secretary who replaced Liza Whitehead.

Prudential Committee report was presented by Kevin Laitenberger. Kevin indicated they need more members, please consider serving. Even if you are not a Prudential member, let them know if you are handy. Need help with cleaning since Lee Marks resigned as we are not seeking out a new Sexton. Kevin indicated that we are running with a high faith offering this year. Need to keep church in prayer. Thanks to team for Clean-up outside and inside.

Wendy H. asked about the memorial garden and getting the stones engraved. Marie C. indicated that the engraver need to have more than one stone to be done to be cost effective. Engraving is buyer cost. Mark H. and Marie to discuss and contact engraver. Seven folks have stones that need engraving. Policy and procedure in place. Garden falls under Prudential. Judy Monarca asked where money for the memorial garden goes — Capital account.

Pastoral Relations Committee – no report; will be electing a new committee

The Auditor's report was submitted by Carolyn Balencia; books look good.

Joe called for a motion to accept all committee reports. Motion made by Johanna F., second by Wendy H., Accepted by all.

Nominating Slate – Discussion on nominating slate and filling open slots. Openings highlighted in yellow. There was a question on the Dates presented on the slate. Dates are from January to January. John Deleo volunteered for Endowment and Prudential. Lisa Swanson and Deb H. volunteered for Endowment. Discussion on whether there needs to be a change and pair down the required numbers for committees. Deb H. indicated that these have already been paired down in the past. Hold this for future discussion. Laura Hall volunteered for nominating. Lisa Swanson volunteered for Pastoral Relations. Kevin made a motion to accept the slate as presented, second by Wendy, approved by all.

Treasurer's report and Budget were presented by Dave Spence. Dave reviewed the budget numbers. Budget based on Pledges and Faith offerings. Reviewed income and expense numbers. This year the mortgage is now included. Discussion on mortgage. Need members to contribute to the Capital fund to help pay the mortgage. Utilities are high. Income 145K, outflow 188 - in summary – running with a deficit of 43K. Lisa Swanson asked about getting an electrical energy audit – Parsonage needs windows. Wendy H. thanked Prudential for all the hard work they are doing. Person who donated water bottles and bags will donate again this year for Outreach. Outreach amount is high but needs to last as 650.00 per month is spent. Dependent on donations. Motion to accept budget, Liza W., Second by Wanda, approved by all. Thanks to Marie for her hard work.

With no other business presented a motion was made to adjourn the meeting by Lisa S., second by Liza W., approved by all. Meeting adjourned at 1:40 PM.

# Pastor's Report to the 153rd Annual Meeting

### Preaching/Teaching:

Beginning in 2023, we continued with our time in the Gospel of Mark. We continued in Mark through the summer before pivoting early fall to a study on the "I Am" statements in John. Before leaving Mark, we made it through the end of chapter 7. The first 8 chapters of constitute Jesus' ministry in the Galilee region of northern Israel. In these chapters, Mark is revealing the Authority that Jesus has as the Messiah, the Son of God. <sup>1</sup> He reveals his authority in several ways:

- 1. Over Sin (Mark 2:1-12)
- 2. In Preaching/Teaching (Mark 1:28)
- 3. Over Satan/Demonic hosts (Mark 5:1-20)
- 4. Over Sickness/Disease (Mark 1:40-45)
- 5. Over Nature (Mark 6:45-52)

In each of these areas, Mark is giving the reader a picture of what it means for Jesus to be the Christ, the Son of the Father. In the words of Eckhard Schanbel, "The question of Jesus' identity is like the proverbial red thread that runs through Mark's Gospel (cf. 1:27; 2:7; 4:41; 6:3, 14–16; 8:27–28, 29; 14:61–62)." In the midst of this revelation, we are also seeing the response of people as they are confronted with the Person of the Son as the very revelation of God. This section (Chapters 1-8: Jesus revealing His Authority as Messiah/Son of God) will find its climax in chapter 8 verses 27-30 as Jesus asks the Disciples "But who do you say that I am?"

As mentioned above, we stayed with Mark all through the summer. Starting September 17<sup>th</sup>, we began a short study of Jesus' "I AM" statements contained in John's gospel. In each of these statements, Jesus is revealing His

Divine Name/Identity as revealed first to Moses in Exodus 3:14. Jesus is saying that He is the same One Savior and Lord of all creation who has always been calling and redeeming His people. The I Am statements are as follows:

- 1. I Am the Bread of Heaven (John 6)
- 2. I Am the Light of the World (John 8)
- 3. I Am the Door (John 10:7)
- 4. I Am the Good Shepherd (John 10:11)
- 5. I Am the Resurrection and the Life (John 11:25)
- 6. I Am the Way, the Truth, and the Life (John 14:6)
- 7. I AM the Vine (John 15:1)

#### Men's Group:

The BFCC men's group is growing! Both in attendees (which is great!) and in their walk with the Lord (which is fantastic!). We have been reading through I Believe (Thom Rainer) since fall 2023. This group of men have a deep desire to dive into God's Word to learn, grow, and mature in their relationship with the Lord. The main event is knowing Jesus and growing together as we chase after Him together. It has been incredibly encouraging to see the Lord bring new faces to the group that desire to pursue that Lord along with the guys that have been attending since this ministry began fall of 2022. Please pray that the Lord would add to and continue to grow each man in this ministry!

#### Youth Group:

We have a very small group of students that meet each Sunday night. We have spent this past fall walking slowly through the first chapter of Ephesians (occasionally pausing to watch an episode of The Chosen). We will continue to work our way through Ephesians this winter as we see Jesus as the Grace, Mercy, and Blessing of the Father given to us for our redemption.

It is worth remembering that the greatest calling I have in serving BFCC is to preach and teach the Word of God in the context of living life with each of you. This is an incredibly important call (1 Tim 4:11-16; 2 Tim 4:1-5). I covet your prayers as my heart is to faithfully serve the Lord and His church at Beacon Falls.

# **Christian Education Committee**

Christian education provides the guidance and teachings needed to glorify Jesus Christ and prepare students for a life of faithful and obedient service to the Lord. An effective Christian education program is one that is committed to working with students of all ages helping them understand the gifts provided by Christ. Beacon Falls Congregational Church offers a growing list of opportunities for young children through adults to continue to see and understand the world through the perspective of God's truth.

#### Sunday School and Youth Ministry:

In late May CEC held "Children's Sunday" to celebrate all that our students accomplished this year and thank our teachers for all of their dedication and hard work in providing a robust and enjoyable Sunday school program. A luncheon was hosted by CEC after service.

On September 10th , the Christian Education Committee hosted our annual Rally Day to kick off the start of our educational year. It included a few new bright and excited faces in our program and it was followed by a luncheon that was enjoyed by all! Rally Day was an enormous success, thanks to our volunteers and those who stepped in to help with the luncheon when it turned out that every CEC member was double-booked on Rally Day- we are thankful for you!

CEC has continued to utilize The Gospel Project as our church school curriculum. The Gospel Project is an exploration of the big story of scripture that follows a plan from preschool through adults. The versatile study allows our teachers and substitute teachers the opportunity to view the upcoming week's curriculum ahead of time from the convenience of their home with a simple login and password. Each week includes an overview video to kick off our session, mission story video, bible story reading and highlights of the bible, and a variety of activities to help our children who may learn in diverse ways. It even includes a fun dance and song video at the end of each unit!

In addition to our early morning Sunday School program for students up to grade 6, we also continued the Youth Ministry program into 2023. Pastor Jess and others welcome students grade 6 through high school each Sunday evening for Bible stories, sharing, and of course a little fun. This Youth Ministry will continue into 2024.

#### Youth Activities and Vacation Bible School:

As a follow-up act to Shipwrecked, BFCC hosted our third "Kids Camp" or Vacation Bible School. The theme of Kids Camp this year was Rocky Railway. Christian Education Challenges of 2023:

The challenges we continue to face include having a sufficient number of volunteers for Sunday school classes and growing the number of students consistently participating in Sunday school.

New in 2023:

The Christian Education Committee has implemented several changes over the past year focusing on providing more options and new varieties of learning for our students. The biggest change was our shift to one multi-aged class, taught in the Fellowship Hall. All are invited to attend our Bible Studies, which are announced in our weekly emails, on our website, on our Facebook site, in our church bulletin, and at Sunday morning services.

#### -Winter/New Year 'The Hiding Place' – by Corrie Ten Boom

We began the year by reading and discussing the real-life account of **Corrie Ten Boom's** account of her family's ministry of hiding Jews from the Nazis during WWII, which resulted in their being arrested and ending up in concentration camps. Corrie's eventual ministry of reconciliation after the war bore evidence of the love for her Lord and His people, as evidenced by her prayer; "Lord Jesus, I offer myself for your people. In any way. Any place. Any time." We were all greatly impacted by her example.

## -Lent: '7 Last Words of Christ from the Cross'. - by Ralph Wilson

Jesus is nearly silent as he hangs on the cross, except for a few words. But these Seven Last Words taken from Luke, Mark, and John provide a window into his soul, and a way to understand what is important to this One who is dying on our behalf.

<u>-Spring: 'The Word of the Lord: Seeing Jesus in the Prophets'</u> – by Nancy Guthrie was our Spring Study. We did the first five weeks of this 10 week guided personal Bible study. As usual, Nancy's relevant teaching, and group discussion, helped us see the person and work of Christ in the prophets: Hosea, Isaiah, Daniel, and Ezekiel. We gained a fresh perspective on the message of the Old Testament prophets, and a broader understanding of Jesus as the fulfillment of Scripture, on this journey seeing Jesus in the Old Testament.

#### - Summer 'Book Club' Bible Study: 'Safely Home' -by Randy Alcorn

Pastor and author Randy Alcorn showed us up close and personal what being persecuted for our faith looks like in this novel about Christians in China. This was very impactful for us. To quote one of our readers; "From the time I started reading this, I couldn't put it down. It grabbed my mind and heart and generated a myriad of questions for me. Could I ever: put my family in danger for Christ? Risk my life for Christ? Risk ridicule by speaking up to coworkers who use our Lord's name in vain. You get the idea. I'm still struggling with those and many more questions."

#### -Fall: 'Blessed: Experiencing the Promise of the Book of Revelation' by Nancy Guthrie

We finally decided it was time to do a study of the Book of Revelation. Having had a years-long experience with Nancy Guthrie's Biblical Studies, we were pleased to hear that she had published this study on Revelation. Nancy showed us how Revelation is less about when Jesus will return and more about who we are to be, what we are to do, and what we can expect to endure as we wait for Jesus to return to establish his kingdom in the new creation.

We were indeed blessed as the study helped us make sense of Revelation's unique apocalyptic symbolism, visual imagery, and Old Testament allusions. Nancy highlights Revelation's call for a costly

allegiance to Christ and a refusal to compromise with the world rather than focusing on interpretive approaches and disputes.

#### - Advent: 'A Christmas Incarnation' by Dr. Ralph Wilson

We did this study in 2015, and decided to repeat to guide our preparation for our celebration Savior's birth. In this study we examined what we know about Mary and Joseph, the Shepherds and the Wise Men, and what it means for us that God planned our salvation to begin with a humble birth which was what took everyone by surprise except those who paid attention to prophesies.

- ► God's Word, is alive and vital to our well-being. Jesus is the only way to heaven. He tells us:

  - "For My Father's will is that everyone who looks to the Son and believes in Him shall have eternal life and I will raise him up at the last day." (John 6:40)

If we really know what God is showing us in the Bible; -we, like the early disciples, can accurately teach others (children, family & friends), by sharing the Good News of salvation in Jesus Christ.

We can also "give a good defense of the hope that is within us"; discouraging the culture's continuing efforts to alter or adjust, or reject Scripture to fit current lifestyles.

We joyfully welcome and invite you to join with us in our Studies and really get to know Jesus through His Word. Whether you are new to knowing Jesus or have known Him for most of your life, He always has something new and amazing to show you.

Special thanks once again, to Liza of our Ministry Team who has gone above and beyond in making our online functions and communications happen so perfectly.

### **Board of Deacons**

As you read this, keep in mind that these are the highlights of the past year. For the full picture you can access the minutes by getting a copy from the church office staff (Lorelei or Liza Whitehead) or the Church Coordinator, Shannon Spence.

Once again, the Lord has been faithful to sustain his church as we are faithful to love, trust, and obey Him.

In January of 2023 we were eager to clean up the membership rolls and update our directory. We have had many new families join us for worship and the directory and membership rolls do not reflect our present congregation. Because other responsibilities took precedence throughout the year, it was never completed so it will be a top priority in 2024.

Another area that we discussed periodically is hosting fellowship after church. The Deacons have been setting up the coffee supplies every Sunday, and the Lord has provided goodies for our fellowships both through some key people who periodically supply them and pure serendipity. We were happy to do this. However, we would like to get the congregation involved in hosting fellowship, so that the Deacons have the opportunity to be in church to greet newcomers as well as fellowship with them after the service. If anyone has ideas as to how we go about getting members of the congregation to host some fellowships, please share your ideas.

We supported the following missions this past year: Heifer International (Martha Berge), Diana Mayela Gomez through World Vision (Judy Monarca), Operation Christmas Child (Lorelei Whitehead), and My Sister's Place

(Wendy Anderson) which was originally for the months of December January, and February but which has now become ongoing throughout the year. All the ministries were well supported except for World Vision. While our yearly obligation is \$468, we collected less than \$150, the excess coming from the Deacon's budget.

We had the following special services: Ash Wednesday where we took of communion and had the opportunity to apply ashes if desired; Palm Sunday where the children distributed Palms to everyone in the congregation, communion was offered, and the service was followed by an Easter Egg Hunt on the church grounds; Maundy Thursday was observed with the Service of Tenebrae which includes readings depicting the road to the cross; Easter Sunday consisted of one 10 am service with communion; the Christmas season services consisted of Advent candle lighting, the hanging of the Greens, the birth of Jesus presented by the Sunday School, and a Christmas Eve day morning service only.

The Deacons hosted two meetings with Brian Prue, one with just the Deacons present and a second with other church leaders invited. The purpose of the meetings was to assess our feelings about the state of the church. This generated the idea for a congregational meeting in February. The purpose of this meeting is to look at where God has led us thus far and to prayerfully discern/develop a vision of where he wants us to go.

Miscellaneous: Each Deacon took a Spiritual Gift Assessment to determine where his/her gifts lie in order to better use those gifts as they minister to those around them; generosity boxes replaced offering plates; more contemporary hymns were introduced throughout the year; when Joe McWilliams was on vacation, praise and worship music was provided by various individuals, including from our own congregation, when we had the pleasure of Denver Joles on guitar and Katy DeLeo as worship leader; we changed our time of worship to 9 am from July until the Sunday before Rally Day which gave families more time to enjoy the warmer weather.

We lost one very special member to the state of Texas, namely Marsha Culik. She was a ray of sunshine, a devoted Christian, and a witness to her faith. We miss her.

We are excited to see where the Lord is going to lead us in 2024. We have found that trusting in Him brings a sense of peace and unexpected surprises. Our future is in His hands.

Most of all thank you God for providing the guidance, love, and these groups of people to help share the love.

Welcome Bags –We delivered 450 welcome bags to-date to new home buyers in Beacon Falls, and we
have fifty on our list that need to be prepared and delivered. As always, thank you to the delivery team
who are always up for a ride around town and the opportunity to meet our new residents. The welcome
bags (with the BFCC logo and mission) include information about BFCC, the town of Beacon Falls, civic
organizations, businesses, a BFCC water bottle, and other goodies.

#### Local Missions

- Annual Easter Egg Hunt We hosted the annual Easter Egg hunt on Palm Sunday with invitations
  to our congregational families and friends and United Day School families. Our church yard was
  filled with candy filled eggs and children looking for goodies. We also had a special visit from the
  Easter Bunny.
- Holiday Dinners We delivered meals on Easter, Thanksgiving, and Christmas this year. Between 50 – 65 meals were delivered to households who enjoyed a meal for the holiday. The need was less than last year, but the need to still very evident. This is not a financial need project but is offered to any Beacon Falls resident or friend of the church who would like a meal for the holidays.
- Halloween Trick or Treat Once again, we participated in the wonderful neighborhood tradition by handing out bags of treats and welcome visitors to the neighborhood. We enjoy this event as much as the trick-or-treaters.
- Beacon Falls Food Bank support for Thanksgiving BFCC helps coordinate donations for the food bank administered by St. Michael's for the Thanksgiving Food boxes distributed in mid-November.
- BFCC Giving Tree Thank you to everyone who helped our three giving tree families this Christmas. The families were so thankful for your support and kindness.
- Christmas Families in need We help coordinate donors with the needs of families during the holidays. Once again, there were about forty families in town that needed assistance during the holidays. These families were given assistance in town and BFCC helped coordinate and supply items through the Care Closet and donations for over twenty of the families. Please see the "New in 2023" section for a description of the Holiday "Shopping" Event this year.
- Lasagna Love (Joann Overby) Our Lasagna Love mission and deliveries is still going strong. Our Lasagna Love group meets monthly and makes Lasagnas that are delivered to families who order a Lasagna or have a friend/neighbor order a Lasagna for them through the Lasagna Love website.
   Lasagnas are typically ordered for households experience a tough time or to celebrate a happy event in their lives anyone who just needs some love.
- Non-perishable Food Delivery (Johanna Fitzpatrick) We continued with perishable food deliveries to our outreach program this year. We deliver fresh food including eggs, milk, bread, etc. to twenty-five families monthly and growing. We also make another delivery with household and personal products every other month to the same households.
- Delivery of food boxes from Food Bank (administered by St. Michaels) (Erika Reichard-Lawton) –
   For households that do not have transportation or are unable to pick up the monthly food boxes,
   the ministry team picks up the boxes from St. Michaels and delivers to the household.
- Delivery of holiday baskets to households with older residents (Johanna Fitzpatrick) Twenty baskets were delivered to households with elderly residents in need. The baskets were beautiful and contained a blanket, candles, soap, puzzle books, and many treats.

#### New in 2023

- O Holiday Shopping Event Johanna had a wonderful idea she has wanted to put into action for some time. We worked with Laurel Ledge, Long River, Woodland High School, and St. Michael's to identify families that would need assistance at Christmas with their children's gifts. The families signed up for a time to "shop" in our fellowship home. All the toy inventory was moved from the care closet to the fellowship hall. This event was a success for a couple of reasons it allowed parents/guardians to shop for the children they know best, and it allowed us to make a connection with the parents/guardians who many times so appreciated knowing they are supported and loved. We were able to share the other programs we offer if they are interested. We will be offering the Holiday "Shopping" event again in 2024.
- Mobile Food Pantry –Jill Mahoney rolled out the mobile food pantry in Beacon Falls with food supplied by Food Share. The mobile food pantry uses the commuter parking lot on Main Street for distribution every other Wednesday. Jill would love to have volunteers help with the program in Beacon Falls, so please see Johanna or Wendy if interested.

#### Looking forward to 2024

- Updating the welcome bags to eliminate paper flyers and including QR code.
- Funding to cover cost of food deliveries, etc.
- Sprucing up the sharing shed paint, move shelves, etc.
- Continue to evaluate the needs of the Beacon Falls community and assess if our programs serve those needs.

# **Endowment Trust Fund Report**

### Endowment Trust Fund Report - 2023 Annual Report

2023 Members: Marie Cameron Chair, John DeLeo, Deb Hogestyn-Treasurer, Lisa Swanson

### Constitution and By-Laws Beacon Falls Congregational Church.

"The purpose of the Endowment Trust Fund (hereinafter referred to as the Fund) shall be to generate supplemental income for the ministry. of the Church through the prudent investment of all gifts and bequests donated to the Fund."

The Endowment Committee met twice and once with Scott Iles from Hammond Iles Wealth Advisors. Hammond Iles investment utilizes the Matson Money (MM) approach which rebalances funds quarterly to help hedge against market fluctuations. We are invested in a Moderate" risk level in 60/40 (equities/bonds) no-load funds. The investment account was established under the church's EIN (Charles Schwab is the custodian) with two signatures for withdrawal. As BFCC is a non-profit organization, Hammond Iles' fee is .10 bps per quarter.

Every month \$300 is invested and transferred from our ION Savings account to our investment account. Also, this year we invested in one lump sum of \$2,800 in donations received from the passing of our long-time member James Woodward Jr. The investment account is reviewed periodically throughout the year.

# **Prudential Committee**

The prudential committee had another busy year in 2023. Throughout the year we have continued to operate with a reduced head count, having only 5 of the 9 members as required by the constitution and bylaws. Nevertheless, we had a number of highlights including but not limited to:

- Spring/Fall Clean-up Another successful year of outdoor and indoor clean-up, Prudential is very grateful for all the volunteers that participated; many hands made light and quick work!
- Elevator Inspection The annual elevator inspection revealed that the elevator is due for a 5-year overspeed valve rupture test. The quote for this test is \$5,768 and is required by law or the elevator will be deemed unusable. We were blessed at the end of the year with a generous donation to cover this necessary test and it will be scheduled in 2024.
- Education Wing Floor Waxing While United Day School was out of session in August a few congregation members took the opportunity to strip and wax the floors in the education wing, which was much needed.
   We plan to continue this on a 2-year basis, with possibly refinishing the Fellowship Hall floor on off years.
   A big thanks to Joe Whitehead and Dave Spence for working late nights to get this done!
- Parsonage Windows 6 of 8 single pane, double hung windows have been replaced with more efficient double pane windows. We plan to replace the remaining two in the spring. A big thanks to Dave Spence for heading this up!
- Parsonage Front Fence- Two 8-foot sections of dilapidated fence were donated and replaced with new, pressure treated 6-foot-high pickets, installed by Dave, John, Jess and Tricia! More fence replacements are planned for 2024.
- Parsonage Master Bath Fan/ light installed and vented outside to mitigate a lack of air movement and conserve heat there. Thanks Dave!
- Parsonage porch awning was falling apart at the seams, we had it re-sewn and the cost was donated.
- Fellowship Hall lights have been failing and are needing to be replaced to meet the needs of the United Day School national or state requirements.
- 10 year Smoke Detectors, maintenance free, were installed around the church. Thanks to Dave Spence.
- Office Administrator In August Tracey Balanca announced that she would be stepping down from the office administrator position due to growing responsibilities in her primary employment. In September the office administrator responsibilities have been split amongst a few volunteers from the congregation with the goal of developing two positions to support the church ministries, Office Administrator and Ministry Coordinator. Candidates for these positions have been identified and salaries have been included in the 2024 Proposed Budget, the plan is to fill these positions upon approval of the budget. We have been truly blessed to have had eager volunteers to carry us through, a huge thank you to Shannon Spence, Lorelei Whitehead, Liza Whitehead, and Judy Monarca!
- Sexton The Prudential committee and other volunteers have continued to take on the cleaning responsibilities through 2023 to alleviate budgetary concerns. The 2024 proposed budget includes an annual expense for cleaning to hire a sexton or outside service. The plan is to pursue filling this role upon approval of the budget. We would appreciate any volunteers to help with the weekly cleaning until the position is filled!
- Fire Marshall Inspection In September we received the report from the annual fire marshal inspection, there were a few minor issues that have been resolved.
- Snow Removal Our plowing contract was renewed for winter 23/24 for parking lot and sidewalk snow removal with no changes to the prices.

On the financial front, the approved 2023 budget had an estimated deficit of more than \$43,000 to known income. Throughout the year all committees operated with prudent spending and the Lord blessed us with some very generous offerings, resulting in an excess of nearly \$2,000. However, a few significant offerings were submitted at the end of 2023 that are specified for the elevator test and mortgage payments in 2024. The mortgage which is financing our Access For All renovation and Elevator expenses continue to be a significant

burden on our financial position and increased by \$3,285 per year (5 year ARM) for 2024. The current outlook for 2024 projects a similar financial position to 2023, however the overall budget has increased by \$23,000 over 2023 with the inclusion of the elevator inspection, mortgage rate increases, sexton fees, office admin/ministry coordinator, employee raises, and other slight increase. The Prudential committee has received a scarce number of pledges (6) for 2024 and therefore is not able to confidently calculate 2024 projected offerings as in past years. Instead, we provide a total offering amount of \$156,000 that will be necessary to meet the budget expenses after Day School and Cell Tower income is subtracted. If 2023 donations are used to project 2024, that leaves an approximate \$58,000 Faith Offering (Deficit). Much prayer and serious consideration must be taken as we proceed with a budget for 2024. The Lord is faithful and has always provided, though we must be faithful stewards of his gifts.




